


1. LETTER FROM THE MANAGING DIRECTOR

In all honesty, at the beginning of 2020, I said to myself: "This will be a fantastic jubilee year, full of positivity, with a pivotal international event in the late fall, a symposium for the 10th anniversary of AIPA at which we will host representatives of all international umbrella organisations for a few days. I had based my optimism at the beginning of 2020 on the business results the year prior, stable revenues and the collection of private copying remuneration, established anew after a decade."

I could not have been more wrong.

The COVID-19 epidemic has cut deep into the fabric of both personal and professional lives. Overnight, we were forced to adopt new ways of working and communicating.

The need for adaptation has stepped into the forefront. Thankfully, AIPA had no problem adapting, particularly thanks to many challenges – even crises – in the past decade, which we have successfully overcome. The key common denominators of successful crisis management at AIPA are the trust and cooperation among the employees and between the board members and the management. I am happy to see that AIPA has both of those deeply encoded in its DNA.

The COVID-19 epidemic has brought about a crisis (which is definitely not only an economic one), and this has, in turn, revealed that companies with focused employees, capable of

critical thinking based on professional knowhow, and companies that trust their employees without the need for controlling their comings and goings have had no trouble adopting a new way of working.

2. BASIC INFORMATION ON AIPA, K.O.

2.1 THE ORGANISATIONAL STRUCTURE AND MANNER OF MANAGING AND SUPERVISING THE COLLECTIVE MANAGEMENT ORGANISATION



AIPA, K. O.

COLLECTING SOCIETY OF AUTHORS, PERFORMERS AND FILM PRODUCERS OF AUDIOVISUAL WORKS OF SLOVENIA, K.O. On the basis of the Copyright and Related Rights Act, the Slovenian Intellectual Property Office (SIPO) granted AIPA, k.o. the Licence No. 31227-1/2008-129 dated on 11 October 2010.

The main goal and activity of the collective management organisation is the collective management and protection of rights of authors, performers and producers of audiovisual works.

- AIPA COLLECTIVELY MANAGES THE FOLLOWING RIGHTS FOR:

 1. co-authors of audiovisual works, that is, the author of the adaptation, the author of the screenplay, the author of the dialogues, the director of photography, the principal director, the composer of the film music especially created for use in the audiovisual work, and the principal animator, if animation is an essential element in the audiovisual work: the right to equitable remuneration for making sound or visual fixations of audiovisual works done within the scope of private or other internal use, and the right of broadcasting retransmission in case of cable retransmission of audiovisual works;
- 2. performers whose performances are used in audiovisual works: the right to equitable remuneration for making sound or visual fixations of their performances in audiovisual works done within the scope of private or other internal use;
- 3. film producers: the right to equitable remuneration for making sound or visual fixations of audiovisual works on videograms done within the scope of private or other internal use.



2.2 REPORT ON ACTIVITIES IN THE FINANCIAL YEAR

The COVID-19 epidemic, which reached Slovenia at the beginning of the year, significantly impacted the planned activities, particularly events. We were, therefore, unable to organise the traditional expert meeting, which we have been organising in cooperation with the SAA and FERA every March since 2017. Because the situation had not improved towards the end of the year, the only meeting in person was the General Assembly session (and even that on a reduced scale). In contrast, all the other meetings were held online.

AIPA - 10 years


On 11 October 2020, we marked the 10th anniversary of the authorisation granted for the collective management of the rights of authors, performers and producers of audiovisual works.

On 12 October 2020, we hosted a press conference at which the managing director Gregor Štibernik and AIPA members (Klemen Dvornik,

Danijel Hočevar and Maja Sever) presented the goals achieved in these ten years and the future challenges.

In light of the 10th anniversary, on 14 October 2020, AIPA hosted an international online conference entitled The Management of Audiovisual Rights in the Next Decade. In attendance were representatives of international umbrella organisations of which AIPA is a member: SAA, AEPO-ARTIS, AGICOA, SCAPR, FERA, and CISAC W&DW.

From 15 to 17 September 2020, we hosted talks with co-authors, performers, film producers, legal experts and administrative employees about the various topics that were the subject of AIPA's activities in its first ten years. Gregor Štibernik hosted the talks. The talks were recorded in printed (a special edition of Megafon, Coffee talks – celebrating AIPA's anniversary) and audiovisual form.



The Directive of the European Parliament and the Council on copyright in the digital single market

The Member States of the EU adopted the Directive on copyright in the digital single market ("Copyright Directive") on 26 March 2019. It was adopted with nineteen votes for and six against (Finland, Italy, Luxembourg, the Netherlands, Poland and Sweden), while three states abstained (Belgium, Estonia and Slovenia). The Member States must incorporate the Directive into their national legislation by 7 June 2021.

Copyright has thus entered the digital age since the Directive calls for fair remuneration for creators and the responsibility of internet platforms. Creators must be fairly remunerated for their work since this is the foundation for further creative work.


In March 2020, the Ministry of Economic Development and Technology asked the interested expert public to submit written positions regarding the implementation of the Directive (EU) 2019/789 of the European Parliament and of the Council of 17 April 2019

laying down rules on the exercise of copyright and related rights applicable to certain online transmissions of broadcasting organisations and retransmissions of television and radio programmes, and amending Council Directive 93/83/EEC, and the implementation of the Directive (EU) 2019/790 of the European Parliament and of the Council of 17 April 2019 on copyright and related rights in the digital single market and amending Directives 96/9/ EC and 2001/29/EC. The due date was 31 March 2020, later extended to 30 April 2020. The submitted positions, including those from AIPA, are published (in Slovenian) on the government website: www.gov.si, tab Novice, Prenos direktiv s področja avtorskega prava (2020-June-5).

No debates, expert conferences or other meetings were organised by the relevant ministry.

Private copying

After a decade, 2020 marks the first continuous collection of remuneration thoughout the entire year. This source is a vital stream of revenue for all categories of right holders: actors, producers




and co-authors of AV works since they represent 20 % of all revenue.

AIPA has attended the General Assembly sessions of Kopriva on 8 January 2020, 24 August 2020, and 23 December 2020.

AIPA General Assembly session

Due to the measures against the COVID-19 epidemic, there was only one AIPA General Assembly session on 16 June 2020, at the hotel InterContinental Ljubljana, Slovenska cesta 59, Ljubljana.

2.3 REVENUE AND COSTS IN 2020



Revenue

In 2020, the total revenue of AIPA amounted to 5,707,101 EUR, which is an increase of 1,029,832 EUR (22 %) compared to 2019.

The revenue from cable retransmission in 2020 was higher than revenue in 2019 by 99,955 EUR (2.1 %)

In 2020, for the first time, AIPA also received remuneration for making sound or visual fixations done within the scope of private or other internal use. These revenues totalled 930,509 EUR, which is 16.3 % more than planned.

Revenues from deposit interest and other finance or unusual revenues in 2020 were 632 EUR (2.4 %) lower than in 2019. The revenue from deposit interest was 6,448 EUR (38.3 %) lower due to the lower interest rates. However, other revenues have increased for a sum of 5,816 EUR (38.8 %).

Costs in 2020

Business costs of AIPA in 2020, comparable to the costs in 2019, amounted to 1,351,052 EUR. However, we must add the impairment of receivables from an attorney in the sum of 123,592 EUR, which AIPA has done in line with the Slovene Accounting Standards (see 3.4.2.5). The share of costs, together with the impairment, in total revenue amounted to 25.84 %, which is still lower than the share of costs in 2019. Without the impairment, the share of costs in total revenue would amount to 23.67 %.


Total revenue and the share of costs in total revenue in the period from 2011 to 2020



vidual subscribers, namely households, hotels, hospitality venues, medical facilities and others.



5. DISTRIBUTION IN 2020

To carry out the distribution, we took the total collected royalties and income from bank deposits in the amount of 4,677,269 EUR. From this amount, we deducted the operating expenses in

2019 in the amount of 1,318,243 EUR and the SCE funds (in accordance with the General Assembly decision made on 16 July 2020) in the amount of 400,000 EUR.


